A Meeting was duly called of MONTGOMERY COUNTY EMERGENCY SERVICES

**DISTRICT NO. 7**, on **February 27, 2025**, at the New Caney Fire Station, 19870 FM 1485 West, New Caney, Texas, 77357.

1. Call to order, roll call, and pledge of allegiance, invocation and welcome guests.
