# 4.TO RECEIVE A PRESENTATION FROM SALES TAX ASSURANCE AND TAKE ANY NECESSARY ACTIONS RELATED TO THE REPORT:

Paula BARK presented the district with the sales tax allocations report for the month of July 2018. # 10. TO RECEIVE A REPORT RELATED TO THE CONSTRUCTION OF STATION 21:

Asst. Chief VENEGAS mentioned that station 21 is still experiencing issues with the air flow, possibly caused by engineering issues. VENEGAS would like to have a letter mailed out either from the Board of Commissioner or the attorney, to find a resolution to this issue.

Attorney to follow up once an air flow test is complete.

# 11. TO RECEIVE AN UPDATE ON THE PURCHASE AND INSTALLATION OF ELECTRONIC SIGNAGE AT ALL DISTRICT STATIONS:

Asst. Chief VENEGAS mentioned that he is waiting on signatures from the HOA association for station 31. No action taken, item tabled.

#### 12.TO REVIEW AND APPROVE MUTUAL AID AGREEMENTS:

Asst. Chief VENEGAS discussed he previously had a meeting with Houston Fire Department and came to an agreement on automatic aid. A written agreement was requested from the districts counsel to have the opportunity for Ariel ladders to respond to box assignments. In return, we would provide one engine and 4 personnel.

Motion by Commissioner ROBINSON and seconded by Commissioner GOMEZ and approved with a vote 4 to 0 to have the district's counsel provide an agreement between the Houston Fire Department and Harris County ESD 24 concerning working together on mutual aid.
