The Harris County Emergency Services District No.24 met in regular session open to the public, at Aldine Fire & Rescue Station 31 on Wednesday, March 18th, 2020 at 20440 Imperial Valley Drive, Houston, TX. 77073.

Commissioner Jerry LOYD called roll at 11:36 am and all of said persons were present: Commissioner Loretta ROBINSON, Commissioner Eva GARCIA, and Commissioner Lee Spilman.

8. TO RECEIVE THE CHIEFS REPORT, INCLUDING FIRE SUPPRESSION, RESCUE AND RELATED ACTIVITIES, AS WELL AS REPORTS ON ANY TRAINING RECEIVED BY THE DISTRICTS PERSONNEL DURING THE PERVIOUS MONTH:

Report for the month of February 2020 presented by Chief PARKER; total responses: 240, total In-District on scene calls: 198, total numbers of apparatus responding: 277, mutual aid: 16, mutual aid received: 0, calls year to date: 463, total training hours: 649.

Chief PARKER informed the board on an erosion problem at Station 21 causing damage to the sprinkler system and pipe lines. Chief PARKER stated that District Chief REEG and Captain SNEATH are working on it to correct the erosion issue. Chief PARKER mentioned that the Conex box has been moved, painted, storage shelves installed, and will soon install vents to make the Conex box cooler. Chief PARKER informed the board that the district should be expecting the new Chevy Tahoe and squad unit to be done by mid-April. Chief PARKER mentioned that he is planning on keeping the old Squad 21 at Station 31 as a backup vehicle. Chief PARKER informed the board that the new pumper is coming along very well. HUT 21 and 11 are serviceable but there are some small things that are continuously being worked on. HUT 21 is waiting for the skid unit to arrive for it to then be installed. Chief PARKER informed the board on the Engine Operator Promotional Exam will take place on April 14<sup>th</sup>, 2020.

Motion by Commissioner GARCIA and seconded by Commissioner ROBINSON and approved with a vote of 4 to 0 to approve the chiefs report for the month of February 2020.

Chief PARKER informed the board that Harris County Emergency Corps dispatch center are taking very specific details when dealing with respiratory calls; dispatchers are only sending medics instead of first responders to these specific calls.
