18. To meet in Closed Session pursuant to Government Code §551.072 to deliberate real estate matters.

19. Executive Session, pursuant to Government Code §551.074, to discuss District personnel matters.
20. To discuss and act on District personnel matters including compensation, benefits, scheduling, retention, hiring and/or termination of District employees.
21. To review, discuss and take action on matters affecting the District's real property.
22. To review, discuss and take action on the purchase, sale, or lease of real estate.
23. review and approve submittals received from the District's Commissioners seeking compensation as permitted by Texas Health and Safety Code §775.038.
24. To discuss any new items which need to be on the agenda for subsequent District meetings.
