

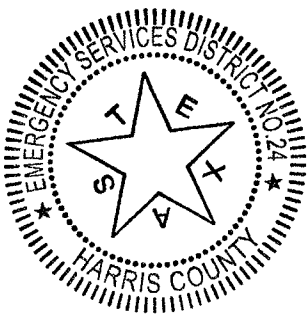
MEETING NOTICE
