

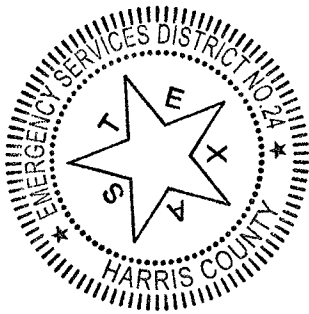
MEETING NOTICE

The District will consider and act upon the following matters:

1. Call to order.

4. To review, discuss and take action to approve the minutes of prior meetings.
5. To review, discuss and take action regarding the Chief's report, including fire suppression, rescue and related activities, as well as any training received by the District's personnel during the previous month.
6. To review, discuss and take action on documents, submittals and change orders requested or presented by BRW Architects or LDF Construction related to the Station 21 construction project, including approval of pay applications.
7. To review, discuss and take action to pay the District's bills.
8. To review, discuss and take action regarding the District's Treasurer's report.
9. To review and take action on revisions to the District's 2017 budget.
10. To review and take action on the District's 2017 Investment Policy.
11. To review, discuss and take action on requests from the Department and Administrative staff for the purchase of equipment, supplies, and other necessary budgetary acquisitions.
12. To review, discuss and take action on hiring an IT company to review the Department's IT infrastructure and to present a proposal for upgrading and replacing the infrastructure.
13. To review, discuss and take action to purchase new computers, servers, printers and other necessary hardware and software for the Department.
14. To review, discuss and take action regarding the remodel or construction of Station No. 11.
15. To review, discuss and take action on any committee reports, findings or recommendations related to the remodel or construction of Station 11.
16. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
17. To review, discuss and take action on additional training needed or required of command staff or other District personnel.

18. To review, discuss and take action to recover missing District property from former employees, volunteers or service providers
19. Closed session under authority of Government Code §551.071, §551.072 and §551.074:
 - a. To review personnel matters, including evaluation of District employees, which includes administrative and command staff, regarding hiring, retention, development, scheduling and benefits, scope of duties and promotion.
 - b. To review real estate matters.
