HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 24

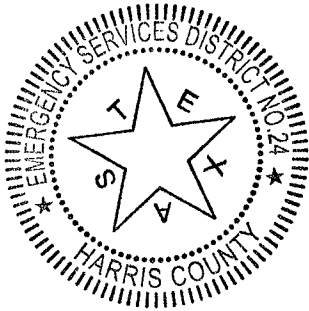

The District will consider and act upon the following matters:

15. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
16. To receive a report from the Department's Public Relations department pertaining to social media updates and events.
17. Review discuss and take action on District personnel matters including actions regarding compensation, benefits, scheduling, retention, hiring and/or termination of District employees including medics, command staff and administrative staff.
18. Executive Session, pursuant to Government Code §551.074, to discuss District personnel matters.
19. To meet in Executive Session, pursuant to §551.071 Government Code, to conduct a private consultation with the District's legal counsel on a matter in which the duty of the

attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter.

20. To review, discuss and take action on submittals received from the District's Commissioners seeking compensation as permitted by Texas Health and Safety Code §775.038.
21. To discuss any new items which need to be on the agenda for the subsequent District meetings.
