

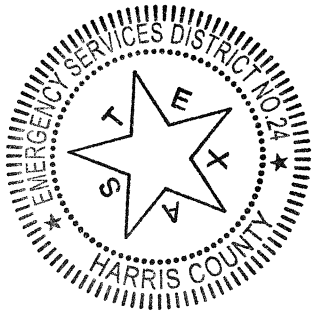
MEETING NOTICE

The District will consider and act upon the following matters:

1. Call to order.
2. Roll call and recognition of guests.
3. Recite the Pledge of Allegiance.
4. To approve the Minutes of prior meetings.
5. To receive the Chief's report, including fire suppression, rescue and related activities, as well as a report on any training received by the District's personnel during the previous month.
6. To receive the Treasurer's report.

8. To review and take action on revisions to the District's 2018 budget.
9. To receive a report from Ron Welch of Municipal Information Services, and take any necessary action related to the report.
10. To receive an update on the installation of electronic signage at all District stations.

13. To review and discuss the District's ISO rating.
14. To approve additional training requested or required of command staff, firefighters, and District personnel.
15. To approve requests made by Department for the purchase or repair of apparatus, equipment, supplies, and other necessary budgetary acquisitions.
16. To review, discuss and take action on items related to Quint 31.
17. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
18. To receive a report regarding social media and upcoming events from the Department's Public Relations representative.
19. To receive a report regarding the Department's 50th anniversary celebration, and to approve expenditures for the event.

20. Review discuss and take action on District personnel matters including actions regarding compensation, benefits, scheduling, retention, hiring and/or termination of District employees including medics, command staff and administrative staff.
21. Executive Session, pursuant to Government Code §551.074, to discuss District personnel matters.
22. To review, discuss and take action regarding the acquisition of real estate for the construction of a fourth fire station.
23. To review, discuss and take action regarding the sale of District real property.
24. To meet in Closed Session pursuant to Government Code §551.072 to deliberate real estate matters.
25. To meet in Executive Session, pursuant to §551.071 Government Code, to conduct a private consultation with the District's legal counsel on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter.
26. To review and approve submittals received from the District's Commissioners seeking compensation as permitted by Texas Health and Safety Code §775.038.
27. To discuss any new items which need to be on the agenda for subsequent District meetings.
