RESOLUTION 2017-12

**A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE REVOLVING
LOAN FUND COMMITTEE; AUTHORIZING THE MAYOR TO APPLY FOR A
WAIVER FOR USE OF RLF FUNDS; AND DECLARING AN EMERGENCY**

WHEREAS, the City of Wauseon desires to construct ramps compliant with the Americans with Disabilities Act (“ADA”) as part of the Downtown Revitalization Project; and

WHEREAS, the City of Wauseon has obtained an engineer’s estimate for the construction of such ramps from Peterman Associates, Inc. in the amount of approximately \$100,000; and

WHEREAS, the City of Wauseon desires to purchase planters as part of the Downtown Revitalization Project; and

WHEREAS, the City has obtained a price estimate for the planters in the amount of approximately \$11,000; and

WHEREAS, the City of Wauseon Revolving Loan Fund Committee has recommended that the City apply to the Ohio Development Services Agency Office of Community Development for a waiver for the use of funds from the Revolving Loan Fund to pay for the construction of the ADA ramps and purchase of the planters; and

WHEREAS, City Council desires to accept the Revolving Loan Fund Committee’s recommendation and authorize the Mayor to apply for a waiver from the Ohio Development Services Agency Office of Community Development for the use of funds from the Revolving Loan Fund to pay for the construction of the ADA ramps and purchase of the planters; and

WHEREAS, this Resolution should be declared an emergency measure necessary for the immediate preservation of the health, safety, and public welfare of the City, and for the further reason that City is prepared to bid out the ramp project and purchase the planters;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Wauseon as follows:

Section 1.

That the recommendation of the Revolving Loan Fund Committee is hereby ratified and confirmed.

Section 2.

The Mayor is hereby authorized to apply to the Ohio Development Services Agency Office of Community Development for a waiver on behalf of the City of Wauseon for the use of funds from the Revolving Loan Fund to pay for the construction of the ADA ramps and purchase of the planters.


Section 3.

That the Mayor is further authorized to execute any and all documents necessary therefore.


Section 4.




