RESOLUTION 2017--14

A RESOLUTION AUTHORIZING THE MAYOR, BY AND THROUGH MAUMEE VALLEY PLANNING ORGANIZATION, TO: ADVERTISE FOR BIDS FOR THE CONSTRUCTION OF ADA COMPLIANT RAMPS ALONG FULTON STREET; ACCEPT THE LOWEST AND BEST BID; AND TO ENTER INTO A CONTRACT WITH THE LOWEST AND BEST BIDDER

WHEREAS, the City of Wauseon desires to construct ramps compliant with the Americans with Disabilities Act (“ADA”) along Fulton Street as part of the Downtown Revitalization Project; and

WHEREAS, certain monies have been properly budgeted and appropriated for this purpose from the City’s Revolving Loan Fund; and

WHEREAS, pursuant to Resolution 2016-10, and the authority granted therein, the Mayor entered into an Agreement For Technical Assistance For The Revolving Loan Fund With Maumee Valley Planning Organization (“Agreement”); and

WHEREAS, pursuant to the Agreement, Maumee Valley Planning Organization has assisted the City of Wauseon with the ADA ramp component of the Downtown Revitalization Project; and

WHEREAS, the Mayor, by and through Maumee Valley Planning Organization, should be authorized to advertise for bids for the construction of the ADA ramps, and accept the lowest and best bid within the budgetary constraints set for said purpose; and

WHEREAS, the specifications for the construction of the ADA ramps are currently on file in the office of the Clerk of Council; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Wauseon, Fulton County, Ohio, as follows:

Section 1.

That the Mayor, by and through Maumee Valley Planning Organization be, and hereby is, authorized to advertise for bids pursuant to Ohio Law and the Codified Ordinances of the City of Wauseon, Ohio, for the construction of the ADA ramps pursuant to the plans and specifications on file in the office of the Clerk of Council.

Section 2.




Section 3.


That the Mayor, by and through Maumee Valley Planning Organization, is further authorized to execute any and all documents necessary therefore.


