ORDINANCE 2017-11

AN ORDINANCE TO APPROVE, ADOPT AND ENACT THE 2017 REPLACEMENT PAGES TO THE CODIFIED ORDINANCES; TO REPEAL ORDINANCES IN CONFLICT THEREWITH; TO PUBLISH THE ENACTMENT OF NEW MATTER; AND DECLARING AN EMERGENCY

WHEREAS, certain provisions within the Codified Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances; and

WHEREAS, Council has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision; and

WHEREAS, the codification of such ordinances, together with new matter to be adopted, the matters to be amended and those to be repealed are before the Council;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Wauseon, Fulton County, Ohio, as follows:

Section 1.

That the ordinances of the City of Wauseon, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2017 Replacement Pages to the Codified Ordinances are hereby approved and adopted.

Section 2.

That the following sections and chapters are hereby added, amended or repealed as respectively indicated in order to comply with current State law:


Section 3.

That the Clerk of Council having caused notice of this ordinance to be published in a newspaper of circulation in the City of Wauseon at least seven days prior to the approval of this ordinance and pursuant to Section 4.13 of the City of Wauseon Charter, this ordinance shall become effective immediately upon approval by a majority vote of the members of Council.


Section 4.

That this Ordinance be, and hereby is, declared to be an emergency measure necessary for the preservation of the health, safety and public welfare of the citizens of the City of Wauseon and is urgently necessary for the acceptance of said annexations and shall be in full force and effect from and immediately after its passage.


