WAUSEON CITY COUNCIL MEETING

Monday, November 18, 2019 at 5:00 P.M.

Mayor Huner called to order this Wauseon City Council meeting at 5:00 p.m. She asked everyone to stand for the Pledge of Allegiance which was followed by a moment of silence. Roll was taken by the Clerk of Council. Present were Council President Stiriz, Councilors Stickley, Schneider, Frey and Stiriz to constitute a quorum for the transaction of city business. Councilor Chamberlin was excused.

Also present were Jodi Rabquer, Toledo Lucas County Port Authority, to explain the energy improvement plan; Matt Gilroy, Fulton County Economic Development Corporation; and Patrick Griggs to observe.

APPROVAL OF PRIOR MEETINGS' MINUTES

Councilor Stickley moved and seconded by Councilor Stiriz to approve the previous meeting minutes.

COMMITTEE REPORTS

Councilor Stickley provided a summary of the Utility Committee report from the November 4, 2019 meeting. He said there was a lot of discussion about putting a check valve on Rick Thompson's line to solve the issue of sewage backing up into his basement. The Public Works department has found and repaired issues in the area which should resolve the sewage backups Mr. Thompson has experienced. No action taken.

INDIVIDUALS WISHING TO ADDRESS COUNCIL

Jodi Rabquer, Toledo Lucas County Port Authority, gave a brief explanation of the PACE energy program. They are able to provide financing to building owners willing to make energy improvements to their buildings. The benefits of this is they are able to offer long term, fixed rate financing for these types of upgrades. They are working on rolling out this program for residential properties as well.

DEPARTMENT REPORTS

Rick Sluder, Fire Chief: Nothing to report.

<u>John Roof, Assistant Police Chief</u>: December 10th is an Explorer Open House at 6 PM. Christmas for Kids is December 14th and the deadline for applications is November 22nd. They are still working on hiring a new Patrolman.

Keith Torbet, Director of Public Service: The generator at the Wastewater Plant is up and running and the Biosolids project is completely done as well. He met with Arcadis about the S. Shoop Ave water line and the plans are going to the EPA for approval. He also spoke with Arcadis about the Enterprise detention pond. A petition went out to individuals in the Pat West and surrounding areas about a storm water tile on Craig Myers' property located at N. Ottokee and Airport Highway. He said this is the first step in the process to get it replaced through the county.

Councilor Stickley asked if the lagoon at the Wastewater Plant has been used this year and was told it has been used extensively as a result of the large amounts of rain and the generator problems before it was replaced.
