Mayor Huner called to order this Wauseon City Council meeting at 5:00 p.m. She asked everyone to stand for the Pledge of Allegiance and afterwards for moment of silence. Roll was taken by the Clerk of Council. Present were Council President Stiriz, Councilors Stickley, Schneider, Chamberlin and Stiriz to constitute a quorum for the transaction of city business. # **DEPARTMENT REPORTS**

<u>Rick Sluder, Fire Chief</u>: Everything went well at the fair. There is emergency legislation for the Clinton Township fire and EMS agreement.

<u>Kevin Chittenden, Police Chief</u>: Lieutenant and Sergeant Positions are posted internally.

<u>Keith Torbet, Director of Public Service</u>: The Zenobia Street project is complete. He is waiting to hear from Mica Construction on the tree damaged sidewalks.

Council President Stiriz said on Shoop Ave at Linfoot the light is not supposed to turn green unless there is someone in the turn lane. Mr. Torbet will look into it.

<u>Jamie Giguere</u>, <u>Director of Finance</u>: She provided the month end reports and the income tax is up a little from previous months. She is getting quotes for health insurance and preparing budgets to distribute to department heads.

<u>Tom McWatters, Law Director</u>: Ordinance 2019-5 is intended to clarify the process for grass that is over 6" tall. He said this ordinance will allow for the city to file small claims in these situations. The trails at Homecoming Park have expanded to roughly 3 acres. They will have trees planted on October 2<sup>nd</sup> by the Tree Commission. Employees from Worthington Steel will install benches.
