# WAUSEON CITY COUNCIL MEETING Monday, January 18, 2016 at 5:00 P.M.

# **Committee Reports**

# Tree Commission - January 13, 2016

Councilor Frey reported the Tree Commission thanked Kim Bowles for submitting the Growth Award that was accepted and awarded to the city. Tom Savage has evaluated the city trees and there are approximately 28 trees to remove. Jim Spiess talked about the community of Bexley that recently received \$25,000 in donated funds toward the purchase of new trees. The Tree Commission would like to see if something like that is possible in Wauseon. Jim Spiess, Pete Carr and Dan Nelson were asked if they would like to serve another term and they all responded yes. Jim Spiess would like Wauseon to be on the list to be a host for Tree City USA in the future. It usually is three to four years out. The Tree Commission discussed Arbor Day observance plans in the spring. The Tree Commission would like to re-evaluate the tree ordinance.

# **Department Reports**

# Rick Sluder, Fire Chief

Chief Sluder reported that he met with the Civil Service Commission and they approved to renew this year's eligibility list for the Firefighter/Paramedic. The test will be given on February 27, 2016. The EMS contract has been signed and will take effect February 1, 2016. The first organizational meeting for the EMS Executive Committee will be on January 19, 2016.

#### Keith Torbet, Police Chief

Chief Torbet expressed condolences to the Danville Police Department and family members in the loss of one of their officers.

Chief Torbet reported that on Friday, February 19, 2016, Mark Weaver will coming up to give a Public Records and Social Media class at the city. We will be offering it to the city employees first and then open it up to other public entities.

Chief Torbet stated that the Police Department will be hosting a Police Leadership class on March 18, 2016.

## Tom Hall, Code Administrator

Mr. Hall said the structure on West Chestnut Street was torn down to make room for the new one.

Mayor Huner asked about an update on the relocation of the Napa Auto Parts Store on Linfoot. Mr. Hall reported that they were looking at next month.

#### Dennis Richardson, Director of Public Service

Mr. Richardson gave an update on the Linfoot St. project. So far this year we haven't had to buy any road salt. He attended the monthly Fulton County Economic Development meeting. There are currently 92 members.
