Council Meeting July 8, 2019 7:00 p.m.

The council meeting of Mayor and Council was held on the above date and time with Council members Dias, Smith and DeBenedictis present with Mayor Letterman presiding. Recording Secretary Sue Muncey, Town Foreman Jeff Hurlock, Chief Carl Hutson, Town Solicitor Scott Chambers, Marvin Pedigo, Jadasa deLeon, Nigel Scott, and David Derrick were also in attendance.

- 1. Call to Order Mr. Letterman called the meeting to order at 7:00 p.m.
- 2. Pledge to the Flag Mr. Letterman led the Pledge of Allegiance.
- 3. Approval of Minutes –

Ms. DeBenedictis made a motion to accept the Street Committee Meeting minutes from 06/05/19, the Council Meeting minutes from 06/10/19, and the Street Committee Meeting minutes from 06/19/19 in written form. Mr. Dias seconded the motion. Motion carried unanimously.

Ms. DeBenedictis stated the Downtown Development Committee will be recommending four applications to the Governor. The Town of Clayton was recommended. We should know an answer in the next couple of weeks. The Downtown Development is an area of the town mapped out as the business district. The state gives money – it is a rebate program. There is a building in town that is need of desperate repair.

11. Public Forum -

David Derrick – Stated he moved here in December. It is a great place. He was made to feel very welcome. He lives at 405 Main Street. At 403 Main Street it smells like raw sewage by the driveway. Also the alley by Fingertip Fantasies – there is debris everywhere. He is asking if anything could be done. Mr. Letterman stated this is the Public Forum. He will pass along to the Code Enforcement Officer. Mr. Derrick also stated many UPS and Fed Ex trucks are going to Hanover. Trucks (18-wheelers) are coming down Main Street at a high rate of speed. The police do a good job, but he is wondering if they can do anything.

Nigel Scott – There is an issue with speeding in Providence Crossing on Coldwater Drive. Mr. Letterman stated there was a discussion earlier this evening and it is being worked on.
