Council Meeting July 9, 2018 7:00 p.m.

The council meeting of Mayor and Council was held on the above date and time with Council members Smith, Dias and DeBenedictis present with Mayor Letterman presiding. Recording Secretary Sue Muncey, Town Foreman Jeff Hurlock, Captain Carl Hutson, Town Solicitor Scott Chambers, Tommy Watts, Tommy Watts Jr., Brian Mast, Charlotte Middleton, Robert C. Johnson, Wayne Gladhill, Rob Wallace, Patrick Gallucci, and Sandra DeLane were also in attendance. Mr. Letterman stated Mr. Carrow was excused from the meeting due to work.

- 1. Call to Order Mr. Letterman called the meeting to order at 7:00 p.m.
- 2. Pledge to the Flag Mr. Hutson led the Pledge of Allegiance.

3. Resolutions –

The Mayor presented a Mayoral Proclamation to the Boy Scouts Pack 239 and Troop 239 for their dedication and service beautifying the Town of Clayton Park on Saturday, June 2, 2018. Mr. Mast stated he wanted to propose that the Boy Scouts do a Town Park clean up in the spring and fall.

The Mayor presented a recognition to Patrick Gallucci for the first graduating class of First State Military Academy.

4. Approval of Minutes –

- Report of the Chief of Police Mr. Hutson stated the department is almost back to full force. They are currently working with funds from the Violent Crime Fund grant received targeting problem areas. There were 56 criminal arrests made in June.

- a. Report from Electric Committee Ms. DeBenedictis had no report. Mr. Hurlock stated we made it through the first heat wave. Mr. Letterman mentioned the PSE&G incident of cutting off power during the heat. Mr. Hurlock stated he wants to review the policy for shutting off power during hot weather. The Town currently has a cold weather policy, but does not have a hot weather policy. We need to re-evaluate. Will contact DEMEC to send out a survey of the other members. Mr. Letterman asked Mr. Hurlock if he knew of any residents where there would be an issue. Mr. Hurlock stated we have had no problems in the past.

Mr. Hurlock stated this will affect the budget. He stated the income will overtake the expense. Mr. Hurlock stated a study needs to be done.

- e. **Report from Personnel Committee** Mr. Letterman stated there is a meeting scheduled for 07/17/18 at 6:30 p.m.

- **g. Report from Budget Committee** Mr. Smith stated a meeting will be scheduled in August to discuss next year's budget and prepare a draft for a three-year plan.

Mrs. Muncey stated he could come to the Town Office and complete the form. Mr. Gladhill wanted to know why the community isn't informed of crimes. He wants to know how they can be informed. How are people notified? He stated in New Jersey people are notified via Facebook. He stated in New Jersey he was a part-time police officer and his chief put stuff on Facebook. Mr. Hutson stated an arrest was made on the stolen car incident. Mr. Gladhill stated the Town of Clayton was named the one of the safest cities in 2016. Mr. Gladhill stated this is 2018. Mr. Hutson stated they also received the same recognition in 2018. Mr. Hutson stated he would speak to him after the meeting. Mr. Gladhill stated moving forward the town's people need to be notified reference criminal activity.
