## *Full-Time FF / EMT Employment Announcement*

**Application Date:** February 1, 2024(*New Application / Testing Process*)

**Job Title:** Firefighter / EMT

**Job Description:** Laurel Fire Department is hiring **one (1) Full-Time Firefighter / EMT** to staff the Career Fire / EMS Division at the Department's main station. The position is currently open to all qualified candidates with an anticipated start date March 15 2024

Under general supervision, successful candidates will perform skilled assessments and administer emergency medical care to patients on site and during transport. Nature of duties involves responding to calls for all emergencies, operating on scene of emergent and non-emergent calls, performing necessary medical treatment for sick and injured patients, and transporting patients to a medical facility. In addition, firefighting duties may include operating fire apparatus, operating Department equipment, fighting fires, and performing patient extrications. Successful candidate will perform duties in accordance with established emergency medical procedures and protocols approved by State of Delaware Medical Direction.

Performance of duties occurs both inside and in outside environmental conditions where extreme temperatures may occur. Candidates must have the ability to work in Immediate Dangerous to Life and Health (IDLH) environments while wearing approved firefighter PPE and Self-Contained Breathing Apparatus (SCBA). Work is performed under the supervision of a Company Officer and is evaluated through peer review/quality management, observation, and performance evaluations.

### **Minimum Job Requirements:**

- Applicant must be at least 18 years of age
- Applicant must maintain a clean criminal background check
- Applicant must be State of DE (or ability to obtain reciprocity) and Nationally-registered as an NREMT-B and must remain dually-certified for the duration of employment
- Applicant must hold a valid American Heart Association BLS CPR certification and must keep the certification valid for the duration of employment
- Applicant must possess a current and valid driver's license with no more than 4 points on their driving record
- Applicant must possess a valid Emergency Vehicle Operator's (EVO) License
- Applicant must have successfully completed Basic Firefighting Skills, Structural Firefighting Skills, Hazardous Materials Response Skills, and Vehicle Rescue through the DSFS or other Department-approved training facility or Pro Board Firefighter I and II

**Work Schedule:** 24/48 with a Kelly-day every 3 weeks (48-hour weeks)

**Starting Salary:** \$20.00/hour negotiable with experience Firefighter / EMT. Paid vacation and sick time, 40 hours of yearly paid training time, Health Insurance, and County/Municipal Pension Plan.
