The solicitation firm was told to cease and given 60 days to turn over all funds that have been collected. 1st VP Smith is working on business cards. Committee sign ups going okay most folks have signed up for Safety and Training Committees. Hope to have all committees finalized by the end of the week and will send out committees with members listed. Ways and Means – the gun bingo was cancelled. We still need to do some fundraising to support the organization. We submitted a SAFER Grant again. The grant was put together by 1st VP Smith, Pete Mellits and Eric Bernard. Current SAFER grant is expiring. The MSFA/MFCA was given a one year extension of the current grant. MFCA secured \$80,000 for training and \$20,000 for marketing. 
Second Vice President's Report:
